
CIRCULAR

In continuation of Circular of even number dated 25.11.2021 and considering the imminent threat of Omicron COVID Variant in the country, which has been declared a Variant of Concern (VOC) by the WHO, the members of the Bar, parties in person and all concerned are hereby informed that out of abundant caution, the present mechanism of listing/hearing of matters shall continue till 24.12.2021, so as to prevent the spread of the said virus.

According to the present mechanism, only fresh admission matters and all miscellaneous applications shall continue to be taken up through video conferencing till 24.12.2021 and two regular hearing matters shall continue to be taken up by affording physical hearing at 2.00 p.m. till 24.12.2021, wherein only advocates will be allowed to remain present.

It is further informed that all the pending routine/non-urgent matters scheduled for listing from 06.12.2021 to 24.12.2021 shall stand adjourned *en block* as under :
