The intending bidders should satisfy themselves about the condition of the air conditioners and stabilizers put up for auction on any working day with prior permission of the Registrar (I/C), Armed Forces Tribunal, Regional Bench, Chennai and no complaints will be entertained after the auction.

- 6. The intending bidders can have the choice to quote the bid amount in a sealed cover and hand it over to this Tribunal prior to the commencement of the auction. The sealed covers containing quotation will be opened in the presence of bidders before finalizing the auction.
- 7. The auction shall be fixed temporarily in favour of the person who has offered the highest bid in the auction or in the sealed cover, whichever is higher and the bidder shall deposit the amount in full within 2 days, less the Earnest Money Deposit.
- 8. The EMD deposited by the bidders except the persons in whose favour the bid is confirmed shall be returned immediately after the auction.

If the person in whose favour the auction has been confirmed fails to deposit the bid amount within the time period, the earnest money deposited by him shall be forfeited and the person in whose favour the auction has been fixed shall be held responsible for loss if any, caused to the Armed Forces Tribunal, Regional Bench, Chennai on conducting re-auction.
