CIRCULAR

Applications are invited for filling up the post of Consultant (SO/TO) in the **Armed Forces Tribunal, Regional Bench, Srinagar at Jammu, Four Majors Qtrs P-6(1 to 4), Military Station Sunjuwan, Jammu** from suitable candidates, who fulfil the eligibility conditions for a period of one year or till such time the post is filled up by a regular official whichever is earlier:-

1.	Consultant (SO/TO)	01	Rs 60000/- (Fixed)	Persons retired from Central Government or State Government or Supreme Court or High Courts or Subordinate Courts/ Tribunals/ Commission:- (a) having retired from level -7 or above (b) Having 05 years experience in judicial work.

2. Consultant should be well acquainted with the functioning of the Central Government / department Courts/Tribunals and various rules/regulations issued by the Central Government, from time to time.

3. Apart from the monthly consolidated remuneration as mentioned above, subject to TDS, Consultants shall not be entitled to any kind of allowance such as Dearness Allowance, Conveyance Allowance, House Rent Allowance, or any other facilities like Residential Accommodation, Personal Staff, Transport, CGHS and Medical Reimbursement etc.


4. Consultants shall be engaged on full time basis and shall not be permitted to take up any other assignment during the period of their consultancy in the Armed Forces Tribunal, Regional Bench, Srinagar at Jammu.

5. Consultants shall be eligible for 1.5 days leave for each completed month of his/her term as Consultant on prorata basis. The un-availed leave will not be carried over to the next year.

6. The engagement of Consultants is purely contractual in nature for a period of one year which may be extended subject to approval of Competent Authority.

7. The engagement of Consultants can be terminated at any time without assigning any reason whatsoever. However, if the Consultant is not willing to work for any reasons whatsoever, he/she will have to give at least one month's prior notice to the office. The decision of the HoD shall be final in all respects.

8. Consultants shall follow the normal working hours as prescribed ie from 09:30 am to 05:30 pm. However, during exigencies they may be required to sit late to complete the time bound work.
9. The maximum age for appointment of consultants shall not exceed 64 years as on the closing date of receipt of applications.
10. The application in the prescribed proforma (Annexure -1) of the eligible officials, who meet the criteria may be forwarded to the **Registrar, Armed Forces Tribunal, Regional Bench, Srinagar at Jammu, Four Majors Qtrs P-6(1 to 4), Military Station Sunjuwan, Jammu-180011** by **25 Mar 2026** along with copies of PPO, educational qualification certificates and Character Certificate.
11. The application received without supporting documents, photograph, unsigned and incomplete in any manner shall be summarily rejected. If any information furnished by the candidate is found false or it is found out that any material information has been suppressed, the candidature of the applicant shall be summarily rejected
12. No TA/DA shall be payable to candidates for appearing in the interview
