- 2. The pay of the individual selected on deputation basis will be governed by DoPT O.M. No 6/8/2009-Estt(Pay) dated 17.06.2010, as amended from time to time.
- 3. The departmental employee in the feeder grade who are in direct line of promotion, shall not be eligible for consideration for appointment on deputation. Similarly, a deputationist in the Armed Forces Tribunal shall not be eligible for consideration for appointment by promotion channel.
- 4. The maximum age limit for appointment by deputation shall not exceed 56 years as on the closing date of receipt of applications.
