CIRCULAR

1. Armed Forces Tribunal, Regional Bench, Chennai invites applications from retired Government servants for engagement as Consultants purely contractual in nature against the below mentioned posts initially for a period of one year, which may be extended subject to the approval of the Competent Authority or till the said posts are filled up by regular basis as per existing Recruitment Rules, whichever is earlier :-

1.	Consultant (Private Secretary)	01	Rs 60,000/-	Stenographers retired from the Central Government or State Governments or Supreme Court or High Courts or Tribunals or Commissions or District Courts or Statutory/Autonomous bodies in Level-7 or above as per 7 th CPC.
2.	Consultant (Tribunal Master/ Stenographer Grade-I)	01	Rs 48,000/-	Stenographers retired from the Central Government or State Governments or Supreme Court or High Courts or Tribunals or Commissions or District Courts or Statutory/Autonomous bodies in Level-6 or above as per 7 th CPC.

2. Consultant should be well acquainted with the functioning of the Central Government or State Governments or Supreme Court or High Courts or Tribunals or Commissions or District Courts or Statutory/Autonomous bodies; and various Rules/Regulations issued by the Central Government from time to time.

3. Except the monthly consolidated remuneration, as mentioned above, subject to TDS, Consultants shall not be entitled to any kind of allowances such as Dearness Allowance, Conveyance Allowance, House Rent Allowance or any other facilities like Residential Accommodation, Personal Staff, Transport, CGHS and Medical Reimbursement, etc.

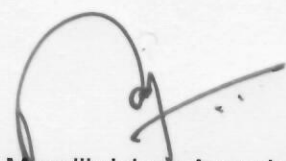
4. The Consultants to be engaged on full time basis shall not be permitted to take up any other assignment during the period of his/her consultancy in the Armed Forces Tribunal, Regional Bench, Chennai.

5. The Consultants shall be eligible for 1.5 days' leave for each completed month of his/her term as Consultant on *pro rata* basis. The un-availed leave will not be carried over to the next term.

6. The engagement of Consultant can be terminated at any time without assigning any reason whatsoever. However, if the Consultant is not willing to work for any reason whatsoever, he/she will have to give at least one month's notice to the office. The decision of the HoD, Regional Bench, Chennai, shall be final in all respects.

7. Consultants shall follow the normal working hours as prescribed from 9.30 a.m. to 05.30 p.m. However, as per exigencies, they may be required to sit late to complete the time bound work on working days.
8. Maximum age limit for engagement as Consultant shall not exceed 64 years as on the closing date of receipt of application.
9. The applications in the prescribed *pro forma* (Annexure-I) of the eligible candidates, who meet the criteria, may be forwarded to the Registrar, Armed Forces Tribunal, Regional Bench, Chennai by **21 Nov 2025** along with copies of PPO and other testimonials/certificates in support of their candidature.
10. The applications received without supporting documents, photograph, unsigned and incomplete in any manner or if any information furnished is found false or if applicant has suppressed any material information, the application of such candidate shall be rejected summarily.
11. The Competent Authority of the Armed Forces Tribunal reserves the right to cancel/vary the vacancies, without assigning any reasons thereof.
12. No TA/DA shall be payable to the candidates for appearing the interview.
