#### CIRCULAR

- 3. The departmental officers in the feeder grade who are in direct line of promotion shall not be eligible for consideration for appointment on deputation. Similarly, a deputationist in the Armed Forces Tribunal shall not be eligible for consideration for appointment by promotion channel.
- 4. The maximum age limit for appointment by deputation shall not exceed 56 years with a residual service of four years on the closing date of receipt of applications.
- 5. The application in the prescribed Proforma (Annexure) of the eligible candidate, who can be spared for deputation /absorption in the event of his/her selection may be forwarded to the Registrar, Armed Forces Tribunal, Regional Bench, Srinagar at Jammu, Four Majors Qtrs P-6(1 to 4), Military Station Sunjuwan, Jammu-180011 by the Department so as to be received in this office latest by 20 Nov 2025 along with photo copies of the Annual Confidential Reports for the last five years (where applicable) of the candidates along with Vigilance Clearance Certificate.
